

# **Annual Congregational Meeting**

Sept. 15, 2024

A call to order was offered by Council President Tom Hutton at approximately 10:35 a.m. Opening prayer said by Pastor Jami Possinger. Thirty-four members were present.

The agenda was presented for adoption. One item was added to the agenda with a motion made by Barbara Laughlin and seconded by Steve Marga. All approved with the agenda as amended.

The Congregation Annual meeting minutes of September 17, 2023, were presented. Peggy Rapp explained that the minutes were drafted by her from memory. The only correction was to add Sara Cornell as elected to the Audit Committee. All approved the corrected minutes.

The minutes from the special Congregational meeting on 5/26/24 in regards to the removal of trees costing approximately \$12,000. Less was spent. Motion made by Peggy Rapp and seconded by Barbara Laughlin.

Nominations for the following positions were read and paper ballots distributed. No nominations came from the floor.

Audit Committee: Ruth Major

Synod Assembly: Phil Newlander, Ruth Major

Nominating Committee: Tom Hutton, Jacquie Halko

All positions were voted on by paper ballots. Slate of all nominees were accepted unanimously.

Annual reports were offered for review from August 2023 to July 2024. Congregational members were encouraged to read all the ministries Faith is involved in. Additionally, special thank you was noted for Pastor Jami and her incredible dedication and gifts shared with us.

The Proposed Annual Budget for 2025 was offered from the Church Council to Congregation prior to meeting. Having been approved by the council, only a second to the motion was needed and was made by Steve Marga. The 2025 Budget was approved as presented.

Old Business-none

**New Business-**

The Church Council made a motion to approve the expenditure of \$53,000 to repave and reline the Church parking lot including the roadway in front which does not belong to Faith. Motion made by Council and seconded by Jan Frantz. After discussion it was deemed by the congregation not to do the road in front therefore spending approximately \$8,200 less. A new amount was proposed by Steve Marga for \$48,000 which is the amount needed to pave, line and repair walkways on Faith Property only. The motion seconded by Brenda Gillis. The vote was brought to the Congregation and majority voted yes. One voted no. No abstentions.

Council also brought to the floor a proposal to spend \$28,300, a tithe of the bequest from William A. Hunters estate. Twenty Thousand dollars is proposed to be sent to Synod and \$8,300 would go to local charities such as Meals on Wheels and the Food Pantry. The motion was seconded by Ruth Newlander. All approved.

Motion was made by Peggy Rapp to close meeting at 11:00 a.m. and seconded by Rick Halko. All approved.

It was the day we began to weave together our diverse gifts, joys, challenges, questions and hopes for our future as a family of faith and as God's disciples in the world around us. It was an exciting day!

However, there is work to do, people to meet and ministry to share so we get on with the work at hand. As you read the articles from other staff, committees and auxiliary organizations of the church in this annual report, you will agree with me when I say we are an active, thriving and vibrant congregation. We are blessed with leadership who are committed to ministry and seeking God's will for us. We are blessed with members who volunteer for all kinds of activities that help our congregation grow in faith. At Christmas time we participate in the TOMEC GIVING TREE for clothing gifts for children of the clients of the Food Pantry.

<u>Faith Fair</u> – see report from the fellowship committee by Sara Cornell. We netted over \$2500 in the 2025 fair – thanks to all who volunteered, baked, cooked, purchased, made baskets, etc.!

<u>Apple Fest</u> of September 2024 – Team led by Lois Childers, many baskets, homemade items, Christmas items and bakery goodies were sold. Soup lunches and quarts of homemade soups were also sold. We reach a goal of just over \$2000.00. The Apple Fest for 2025 will be on Saturday, October 4<sup>th</sup>. Hope to see you there.

<u>Christmas Cookie Event:</u> Baking ladies of our church provided a myriad of different kinds of cookies which were sold in packages put together by our Faithful Ladies. Over \$400 was raised for the church.

<u>Souper Bowl</u>: this fund raiser which happens during Super Bowl month raises money for the Food Pantry run by TOMEC (Top of the Mountain Ecumenical Council). Faith congregation has always been generous in supporting our local charities.

<u>Buck A Chick:</u> a fund raiser held for National World hunger, unfortunately, did not happen this past year.

<u>The American Red Cross blood drives</u>: thanks to Phil Newlander. Happening every other month. Many lives have been saved because the blood drives have been very successful. Check the schedule and join us if you are able.

# FAITH LUTHERAN CONGREGATIONAL MEEING FELLOWSHIP TEAM -COMMITTEE REPORTS SEPTEMBER 28, 2025

#### Faith Cookbook:

The Faith Cookbook project is still a work in progress. Several recipes have been collected from church members, but not yet enough for an entire book. Hopefully, we will gain some renewed interest in this project during this fall and winter, so we urge everyone to submit their favorite recipes so we can complete a cookbook for our members.

#### Faith Fair:

Faith Fair was held Saturday, August 9, 2025. The Fair featured flea market and craft vendors, sales of used books, jewelry and purses, bingo games, cake walks, and delicious food and baked goods. Pastor Moore and Rick Halko provided music. In addition, baskets were raffled, and tickets were sold for a guilt to be raffled at Applefest in October.

#### Faith Fellowship Team:

The Faith Fellowship Team was initiated in May 2025, to promote community and church fellowship and interaction. Since its inception, Faith Fellowship Team has participated in a bake sale for the National Service Animals Monument local dog walk (May), held a presentation entitled, "Positivity and Joy in a Challenging World" by Sara Cornell (May), held a Bingo! event (June), and a Movie and Ice Cream Sundae Sunday for children ages 4-12 (July). The August Fellowship Team event was the Faith Fair.

#### Faithful Readers Book Club:

The Faithful Readers Book Club currently has 10 members. Each month has featured a different book, lively discussion, and brunch at the Chat N Chew Cafe. Books read have included: The Women, The Women's March: A Novel of the 1913 Woman Suffrage Procession, And Then There Were None, The Extraordinary Life of Sam Hell: A Novel, The Hotel Nantucket, Pawprints on Our Hearts: How A Few Incredible Dogs Changed One Life Forever, Remarkably Bright Creatures, By Any Other Name, and When the World Tips Over. The book club will be resuming later in September after a summer hiatus.

#### Faith Library:

The Faith Library is a small library located in the back of the church. The library is available to all church members and consists of a diverse selection of both children's and adult books. A sign-up sheet is available for those wishing to borrow books. Books may be donated if they are faith-based.

#### Fellowship Outings:

There have been many fellowship outings this year. Some have been more heavily attended than others, but they have been a great way to interact and learn more about our members. Since last fall, we have gone to Stoddartsville Historical Center; the Larry Cook, Historian Center at Hoyt Library in Kingston; and the National Canal Museum in Easton.

#### **ALTAR GUILD**

2025 has been the first full year of traditional communion distribution during worship, since the pause during the COVID Pandemic driven changes.

Many volunteers facilitate the communion portion of the service. Some of these tasks may not be visible to the congregation on a weekly basis. Bread needs to be baked, linens must be washed, cups placed in the trays, cups must be removed from trays after use, the sanctuary is cleaned as well as the chalice and plate that Pastor uses during distribution. In addition, this committee also coordinates the weekly schedule for communion assistants.

Special thanks to Phil and Ruth Newlander who frequently prepare the elements before each service.

The committee also is responsible for flowers to brighten the sanctuary during holiday services.

The dedicated staff of the Altar Guild works in small groups and serves monthly to get the altar ready for church services. There are four sub-committees. They are as follows:

Flowers, juice, linens, and bread.

Anyone willing to chair one of those sub-committees is more than welcome, so please let me know!

#### Music at Faith 2025

Music continues to be a large part of our worship here at Faith. Each Sunday service includes at least three hymns, service music, and prelude and postlude. Services also sometimes include special music or additional hymns for special occasions.

In addition to music at weekly services, we also have a choir of 13 members that rehearses each Sunday from September through May from 8:30 a.m. – 9:15 a.m. on Sunday mornings. They sing a variety of musical styles and share their music with the congregation about once a month. New members are always welcome!

Molly sits as part of the Music Planning Committee, along with Peg Rapp, Rick Halko and Pastor Jami, to choose hymns and service music for Sunday services. The group meets 3-4 times per year and prayerfully chooses music based on the readings of the day and the liturgical season. The group considers the familiarity of music, good times to introduce new music, and feedback received from the congregation. This group also selects liturgy for worship services. For the Pentecost season, we've utilized settings 1 and 2 from Lutheran Book of Worship, along with the Russian Orthodox Kyrie, Celtic Alleluia, and post-communion song from the Bread of Life Setting of With One Voice. Beginning in mid-September, the service music will change to include Setting 10 from Evangelical Lutheran Worship and Setting 5 of With One Voice, as well as a new Kyrie, Offering Song and Post-Communion song. We will continue to use this new setting for the next several months, with small changes to reflect the changes in liturgy during the Advent and Christmas seasons.

Molly continues to send copyrights to the church secretary so that they can be included in the bulletin each week. This enables us to print music in the bulletin as well as live-stream and record what is played during services. She also reports all of our music used each week to our two licenses, CCLI and OneLicense.

We were blessed once again to have some volunteers from the congregation provide us with chime music in the winter, after eight weeks of practice. If time and schedules permit, we will hopefully have chimes players for the fall of this year as well.

Molly also provides music for scheduled memorial services and special services, like the Christmas Program, throughout the year.

As always, it is a privilege to hear this congregation lift their beautiful voices in praise each week and to hear the musical talents that so many members are gifted with. If anyone is ever interested in sharing some special music during services, please reach out to Molly.

# **Summer Concert Committee Report—2025**

The 2025 Summer Concert Series was a bit more abbreviated than prior years, but the results were outstanding.

In July we had a fabulous performance from Poor Man's Gambit, an Irish American trio who had performed for us several years ago. Attendance was strong at 67 and we received \$313 in freewill donations. Special thanks to Molly Finkbiner for connecting us with these wonderful musicians.

In August, we were fortunate to have Beth Goldwater and Kyle Swartzwelder return for a program of soft jazz from the Great American Songbook. Beth sang two years ago, accompanied by Kyle on guitar, and last summer Kyle gave a solo performance, both singing and playing. We had an audience of 52 and an offering of \$260.

Attendance was up from an average of 35 the previous year. This year, we opted to have a basket for offerings at the back of the sanctuary rather than passing a plate during the performance. Offerings per concert were similar to 2024, but were markedly lower per attendee.

Special thanks to Mike Gillis for faithfully putting up (and taking down) the banner announcing our concerts, and to John Lyman, Peggy Rapp, and Judie Tim for assisting with the logistics involved in opening and closing the sanctuary.

Since the Rays will be moving, the congregation will need to develop a new committee if this community service effort is to continue.

August 2025 The two air conditioner/heat pump units were approved and

replaced.

As of **September 2025**, all maintenance items are up to date. The volunteers are keeping the grass cut and the flowers cleared.

Finance and Stewardship Committee Annual Report

(August 2024 through July 2025)

2025

The 2025 budget was developed by understanding our income vs expenses for the last year. Our

2026 budget builds on our experience and focuses on maintaining our infrastructure while continuing our

detailed stewardship of church funds.

Our electronic giving capability, introduced in 2019, is not being utilized to the level it was during

the pandemic. The finance committee continues to recommend the use of the online system for regular

recurring donations. This allows us to accurately track our income in the most efficient manner.

As we reported last year Faith received a large contribution from the estate of Bill Hunter. The

estate has not been finalized, and Faith has been informed that we will be receiving additional funds as

the distribution of the estate is completed. The Finance committee along with the council has worked to

be good stewards of this donation. A large portion of these funds have been invested through Thrivent

to Faith every week keeping track of our income and tracking our expenses as well as making sure our

employees and vendors are paid on time.

Proposed changes to the Constitution of Faith Lutheran Church, Blakeslee, PA

# Section C12.05, subsection C reads:

The Congregational Council may enter into contracts of up to \$2000.00 for items not included in the budget.

# Section C12.05, subsection D reads:

The Congregational Council shall prepare an annual budget for adoption by this congregation, shall supervise the expenditure of funds in accordance therewith following its adoption, and may incur obligations of more than \$2,000.00 in excess of the anticipated receipts only after approval by a Congregational meeting. Etc.

The Congregational Council proposes to change the highlighted dollar amounts in Section C12.05, subsections C & D from \$2,000.00 to \$5,000.00.

Rationale: The \$2,000 limit in both these sections was established many years ago and has not been updated to account for inflation and rising prices. The proposed changes give the Congregational Council more appropriate decision-making latitude without necessitating a Congregational meeting.
